2. Work Session

- A. Discussion of Financial Planning and Levy Options and Presentation TIFs

Dr. Rateno started the meeting by giving an update on the stadium lighting. On Sunday, June 14, one of the stadium light poles fell in a storm and landed on two new vans parked nearby. No one was in the stadium at the time. The pole was removed on June 17. The stadium will remain closed until the remaining poles are inspected and removed if necessary.

David Seed talked about the Casement TIF. He explained what Tax Increment Financing (TIF) is and the collection schedule for a TIF. Mike Prcela talked about the Shamrock and Encore TIFs that are currently in place with Painesville City.

Dr. Rateno said that he received a letter from the state taxing agency saying that \$13.8 million would equate to a 1% earned income tax. This would be equivalent to a 7.89 mill property tax levy. The distribution percentages for the operating budget and permanent improvements are in the resolution but will not be in the ballot language.
