**Resolution #2026-01-12 – Approve Pick-Up Pay for Deputy Director of OESCA**

**Be It Resolved**, in accordance with O.R.C. Chapter 3307 and in addition to paying the employer’s share of the STRS contributions as required by law, the Governing Board hereby agrees to “pick-up” (pay directly) the employee’s share (in the amount of 14%) of the employee’s total retirement system contribution to the STRS for the position of Deputy Director of the Ohio Educational Service Center Association (“OESCA Deputy Director”). The OESCA Deputy Director is an administrator employed by the ESCNEO pursuant to O.R.C. 3319.02. This pick-up shall be a condition of the OESCA Deputy Director’s employment by the Governing Board and shall not be at the employee’s option. It is the intention of the parties that this picked-up amount be included in the employee’s compensation for the purpose of calculating retirement benefits.
