#### PRESENTATION BY SPEAKERS

### Christopher Cox - Financial Advisor with Voya Financial

Mr. Christopher Cox, a financial advisor with Voya Financial, presented on various aspects of the 403(b) and OASBO 457(b) employee retirement plans. He explained Voya's role in managing the plans and his role in educating employees on their retirement plan options. Mr. Cox also discussed the role of TSA Omni as the third-party administrator for both the 403(b) and OASBO 457(b) plans. He emphasized that none of these services carry a cost to the district.

He described his services to include group presentations (employee education), one-on-one meetings (in person or virtual), retirement plan enrollments, and investment reviews for employees. These offerings help ensure that employees are informed about and understand the retirement plan options available to them. Mr. Cox also described services designed to help employees map out their retirement years, allowing them to visualize when they can retire. Additionally, these services show how changes to retirement savings can impact an employee's projected retirement date.
