Additionally, the district has a medically fragile student in which a full-time health aide is required. With the help of the health aide, the student is able to be fully included in the classroom, providing medical support as needed. These funds play a crucial role in fostering a supportive environment and helping students thrive academically, personally, and emotionally.

Both of these partners assist with meeting the healthcare needs of our students. These services are coordinated through collaboration and identifying the medical needs of our students. Professional development opportunities also occur throughout the school year to assist in the medical needs of our students.

The Student Wellness and Success Funds provide access to healthcare professionals, Guidance Counselors and SRO's for our students. Students are also screened for hearing and vision as required. Providing healthcare services allows for community connections where families' healthcare needs can be met. All students in grades preschool through twelfth grade have access to a healthcare professional during the school day, which assists local families. The Nursing Aide assists the School Nurse by meeting the healthcare needs of our students, student attendance is expected to increase due to the support of the school nurse. The funds will provide our Students with two Guidance Counselors. They will be utilized to provide Mental Health Interventions for our students. In addition to these services, they will help guide our students in their career pathways. We will provide two SRO's for the district. They will be involved in safety planning and the implementation of this plan. They are also heavily involved in providing our Building Administrators with student discipline and attendance.
